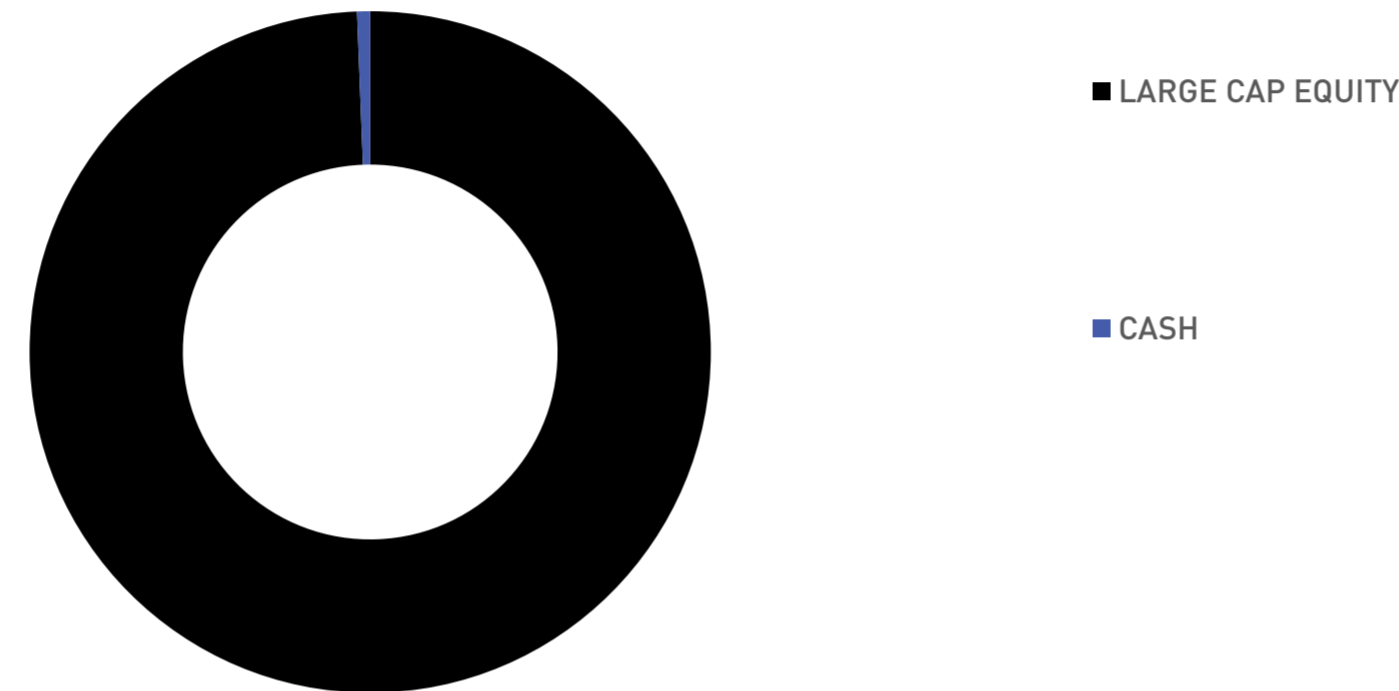
STRATEGY OVERVIEW

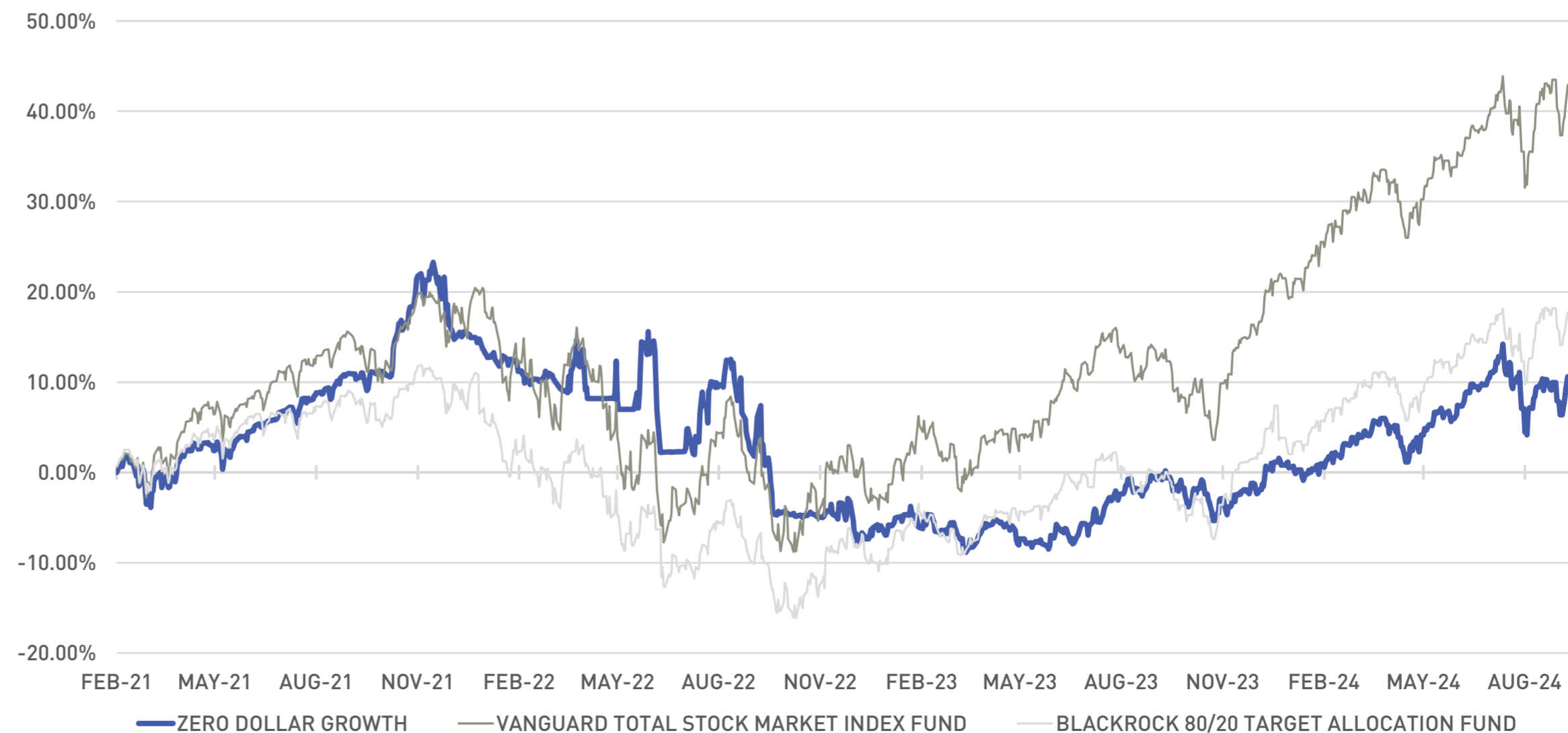

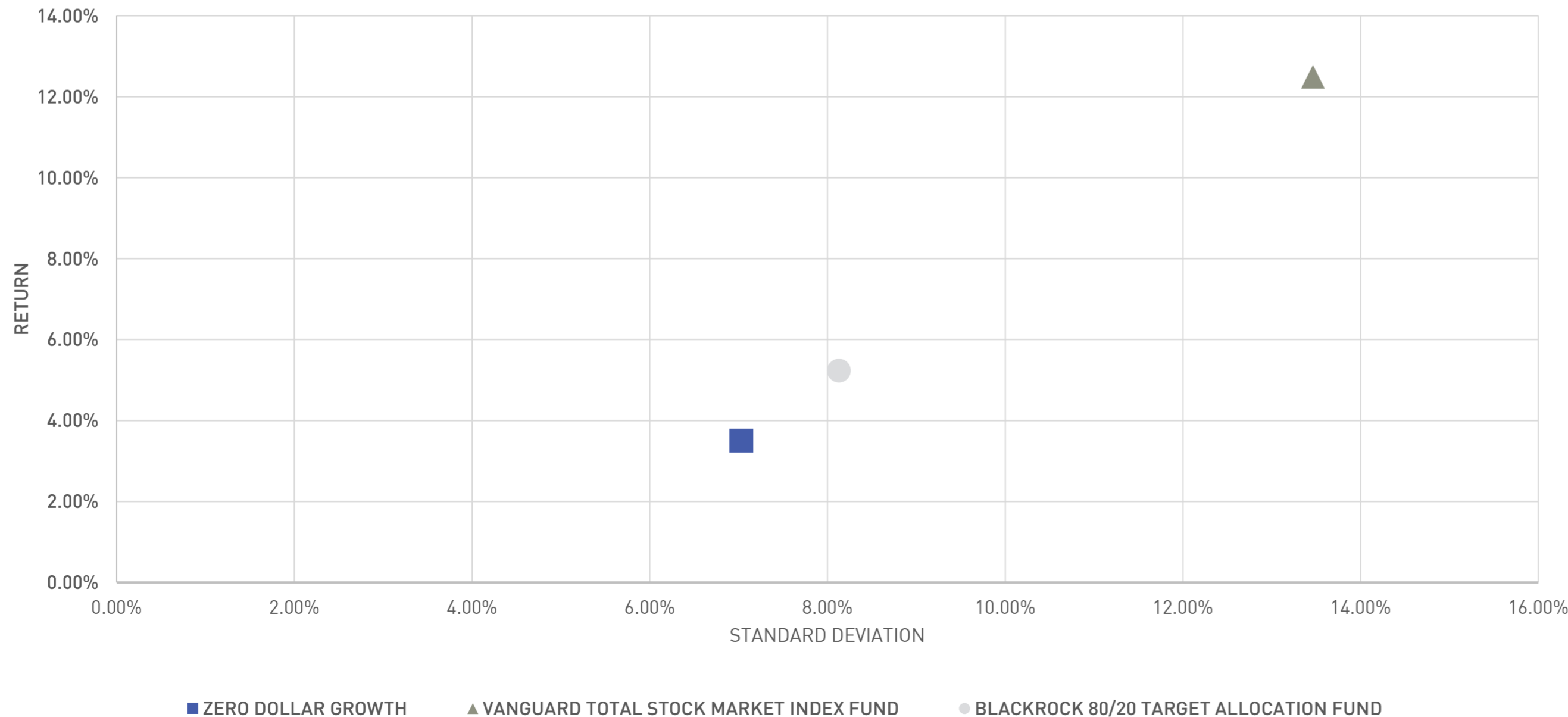
